(internal quotation marks omitted). thus, nejman did not sufficiently allege that he had not breached his duty to disclose in his original complaint. finally, nejman argues that we should overlook his failure to allege a cause of action because the district court considered his response to the defendants’ motion to dismiss to be a second amended complaint. we have held that “a district court may consider only the allegations contained in the pleadings on the date of the order on a defendant’s motion to dismiss,” unless the district court construes the complaint to be amended by incorporating documents by reference. united states ex rel. zavier v. laurentide foods, inc., 834 f.3d 688, 692 (8th cir. 2016). nejman argues that the district court incorporated documents by reference because it “considered the relevant documents, including the plaintiff’s response to the defendant’s motion to dismiss and supplement, in reaching its ruling.” but nejman did not incorporate any documents by reference into his response brief, and the documents he does mention are not relevant to his allegations. we therefore decline to consider them. see fed. r. app. p. 28(a)(8)(a) (requiring appellant’s opening brief to include “appellant’s contentions and the reasons for them, with citations to the authorities and parts of the record on which appellant relies”). 5ec8ef588b
